About the Foresight Prep Impact Institute

The Foresight Prep Impact Institute brings together an intimate cohort of 10, highly motivated students passionate about social justice, climate change, and other urgent issues, who will accelerate their social and environmental change leadership by exploring multiple levers, methods and approaches for creating change, from the “people power” of social movements, to urban design and planning, policymaking, corporate social responsibility, entrepreneurship, the arts, and others.

Through a dynamic mix of classroom activities and lectures, guest speakers and field trips, hands-on projects, and meaningful relationship and community-building, students will emerge better equipped to address complex social and environmental challenges throughout their future education and career paths, supported by a network of like-minded peers, staff/faculty, and “real world” change-makers.

PRINCIPLES

Foresight Prep's curriculum is shaped by five principles:

Insight Into Social Justice, Sustainability and Change-making Methods

Foresight Prep focuses on "the how," not just the "what," exploring a range of different change levers, such as organizing, urban design, policymaking, business, and more, informed by diverse practitioners. Students evaluate issues and approaches systemically, including their interdependencies and root causes, and synthesize this information to form their own perspective about how to most effectively address complex challenges, and develop their own emerging toolkit of strategies.

Leadership

The program builds students' capacity to affect positive social change by identifying and cultivating their leadership skills and potential. This process is facilitated by a holistic curriculum that recognizes the uniquely collaborative and innovative leadership that is required to address complex and rapidly evolving problems.

Diversity, Equity and Inclusion

The program seeks to cultivate future leadership that is more racially, economically and geographically diverse and inclusive, and representative of the communities that are most directly affected by social and environmental challenges, and to expose students from across multiple identities and experiences of power, oppression and privilege to a diversity of perspectives and concerns.

College and Career Preparation

The program facilitates students' personal and professional development in preparation for the next steps in their journey. Experiential learning opportunities are prioritized over passive instruction. Hands-on projects develop skills for primary and secondary research and analysis, while discussions help students reflect upon paths for achieving social impact and personal fulfillment.

Ongoing Mentorship

A four-week experience can only provide an introduction to complex topics. Program alumni become part of an ongoing network connecting them with other like-minded high school students, college mentors and established change-makers, to support their future engagement.

VALUES

In addition to the above principles, Foresight Prep's adult staff are working to internalize the following values for our community, in order to keep us accountable in our partnerships with our students and other young people:

Positive Youth Development (PYD)

PYD is a strengths-based approach to youth programming that views all young people as assets to be developed, rather than potential crises requiring intervention. It is operationalized through focusing on what the researcher Richard Lerner calls the "five C's": Competence, Confidence, Character, Connection, and Caring, which lead to the sixth C of meaningful youth Contribution. Our emphases on experiential learning, positive community building, and student leadership and decision-making, are some of the ways that we pursue PYD.

Undoing Adultism

Adultism is a system of oppression that privileges adults and marginalizes youth and children. Structurally, youth are excluded from decisions that affect their lives. Culturally, they are often viewed as less capable than they are, based upon socially constructed stereotypes and questionable interpretations of the science of human development. Foresight seeks to begin dismantling this system by honoring youth voice, expertise and experience, and creating opportunities for our students to participate in decision-making and mutually accountable partnership with our adult staff.

Anti-Oppression

We acknowledge that the life experiences of all individuals in our community have been shaped by intersecting systems of power, privilege and oppression related to race, class, gender, sexuality, ability and age. We hope to facilitate an environment where both students and adult staff can better understand and acknowledge our own and one another's experiences of both privilege and marginalization, and how they shape our current and future work as change-makers.

"Safer" Space/Brave Space

We seek to foster an environment where all students are able to bring their whole selves to conversations that may at times challenge them and generate discomfort, without fearing that the classroom environment may inflict new or perpetuate existing harm. We acknowledge that we cannot in good faith promise safety, but can create a process that aims for mutual accountability and learning.

Trauma-Informed

While our staff are not trained mental health providers, and cannot always anticipate every individual survivor's specific triggers, we strive to facilitate mindfully, knowing that the members of our community bring different lived experiences related to social and environmental topics, some of which may include known or unknown trauma.

Holding Space

Our staff seeks to make ourselves fully present to any students who share with us that they are struggling, within or beyond our program, and to do so without judgement.

Transformative Justice

When situations of conflict arise between members of our community, including violations of our policies (set by Foresight's staff to ensure the safety of minors in our care, and address legal liability) or collective agreements (guidelines created in partnership with students), rather than responding solely punitively, our highest aim is that the situation becomes an opportunity for positive and inclusive transformation of our learning community.

Student Experience Overview

TYPICAL DAILY SCHEDULE

The average daily schedule includes three and a half hours of class-time each morning, with afternoons more focused on the execution of group project work. This schedule will vary on field trip days, when students will be off campus for the majority of the day. The formal classroom component of the program is five days a week. Each day on campus incorporates an hour or more of afternoon free time, and there will be planned social and community-building activities during the evenings and weekends that will supplement the learning experience, as well as ample time to informally socialize and (safely) explore the city.

PRE-CURRICULUM

Two weeks prior to the beginning of their session, students will participate in an online pre-curriculum, for which they should plan to dedicate about two hours weekly for non-synchronous independent work and web-based discussion with peers and instructors.

The pre-curriculum offers the opportunity for students to begin building a common understanding of the Institute's topics, beginning with their own communities and lived experiences, and anticipation for meeting their peers in person. Accommodations will be made for students' family and summer travel schedules, as well as technology limitations.

TRAVEL

Timeframe

Residential hall check-in will take place between 12:00 and 2:00 PM on Sunday June 25, and program activities will begin at 3:00 PM. (accommodations may be made for students who must arrive later in the day due to geographic or financial needs). Foresight Prep staff will be onsite at the residential hall earlier, for students who are already on campus and wish to drop off their baggage, or wait with staff until check in begins.

An informal lunch will be available to students during check-in. Lunch is designed to be a space for students to begin becoming acquainted with one another, and solidify their social community. Parents arriving with students are welcome to stay just long enough to help students settle into their dorm, after which Foresight Prep staff will provide parents with a list of local dining and recreation options.

Breakfast will be served on the closing Saturday, and will be the last scheduled activity.

Air Travel

Students traveling by air will fly into either O'Hare or Midway International Airport, arriving on Sunday, June 25, and departing on Saturday, July 22. On arrival day, Foresight Prep staff will greet students at the airport between 9:00 AM and 4:00 PM, and help connect students with transport to campus. On arrival days, students are requested to schedule flights no later than 4:00 PM, and on departure days, no earlier than 9:00 AM. This is to ensure our staff's capacity to provide transportation support, and student participation in arrival day community-building activities. Based upon financial need, accommodations may be made for flights outside this window.

Alternative Modes

Students wishing to arrive or depart from Chicago by other modes than train or car (e.g. bus, train) should plan for their own travel to campus (i.e. by public transit or ride share), with which we are happy to provide advice and support for planning.

Safety & Communication

Students are expected to notify parents/guardians of their safe arrival on campus, and Foresight Prep staff when they have reached home at the conclusion of the program.

HOUSING

As Foresight Prep places a strong emphasis on community building, all students are required to live with their cohort in campus housing. Students will occupy double occupancy rooms. Foresight Prep staff put great care into selecting roommate pairings to ensure a positive experience. All rooms are air-conditioned and fully furnished with an extra-long twin bed, desk and chair, and dresser.

RESIDENTIAL/TEACHING ASSISTANTS

Residential/Teaching assistants (RATAs) will live with students in the residence hall and will help mentor students and ensure their safety and a positive experience within the classroom and dorms. They are responsible for ensuring compliance with all program policies and guidelines and will be an important resource to students. They will remain on call 24 hours a day.

CAMPUS SAFETY

Loyola University Chicago's robust [Campus Safety](#) protocols and Foresight Prep's policies and staff oversight will ensure students' safety while in Chicago. Students will be expected to adopt a buddy system and regular check-in schedule while on campus and in the immediate area, and off-campus excursions will be chaperoned by program faculty and staff.

STUDENT GOVERNANCE

At least twice weekly, with support from the Residential/Teaching Assistants, students will meet together in the dorm to practice shared leadership and decision-making focused on their residential community. This includes determining the collective agreements that will guide students' behavior within the dorm and toward each other around key topics such as usage of the bathrooms and common areas. This will also be a forum for addressing community conflicts and challenges, and for planning and pursuing group undertakings such as student-led social activities.

DINING

Three daily meals will be provided in a student dining hall, with a box lunch provided on field trip days. Special diets and food allergies will be accommodated with advance notice. For the purpose of both student safety and community-building, meal attendance will be mandatory.

CLOTHING, LAUNDRY, AND PACKING

A full suggested packing list will be provided to students closer to the start of the program. Chicago weather can vary widely, even during the summer. Students should be prepared for the possibility of high heat (as high as 90-95 degrees Fahrenheit) and humidity. Light clothing, as well as a warmer layer in case of cooler weather, and an umbrella or rain jacket will stand students in good stead. Students should bring one nicer business casual outfit (e.g. slacks/skirt and shirt/blouse) for specific field trips. The dorms have laundry facilities operated by pay cards that can be purchased on site. Students will need to provide their own detergent, iron and clothes hangers, if needed.

In addition to clothing, students should bring a notebook, pens, and for field trip days, a water bottle. Students are encouraged to bring laptop computers, if available, and will have access to the

wireless network. For students without access to laptops, arrangements will be made by Foresight Prep staff.

CLASSROOM FACILITY

Class sessions will be primarily held in Loyola University's Institute of Environmental Sustainability. The building contains classrooms, faculty offices, research and teaching labs, a biodiesel lab, an urban agricultural greenhouse and aquaponics facility, and, during the school year, a green café. It has state of the art sustainability features to maximize natural resources and divert, reuse and repurpose waste, including a stormwater management system, rainwater capture, a geothermal system, and green roofs.

FIELD TRIP TRANSPORTATION

Transportation to site visits off-campus will be through a combination of public transit and chartered or rented vehicles, depending upon logistical needs as well as the evolution of Covid safety protocols.

Student Social, Residential, and Academic Policies

POLICIES VS. AGREEMENTS

During the program, students will have the opportunity to shape their own collective agreements to establish mutual respect and a positive community in the classroom and residential space. What follows are the non-negotiable policies we must establish in order to ensure a safe environment for the minors in Foresight Prep's care. Violations of any of these policies are subject to Disciplinary Action (see below).

COVID POLICY

The health and safety of our students is of the utmost importance. Our decisions are based on guidance from the Centers of Disease Control and Prevention, other public health experts, and Loyola University Chicago health and safety protocols. We will adjust decisions based on public health conditions and guidance. All students, staff and faculty must be vaccinated, in accordance with Loyola University Chicago's requirements. Decisions regarding protocols for the classroom, field trips, and social outings and activities will be made based upon current recommendations from public health experts, and to prioritize student health and safety.

PROGRAM REQUIREMENTS

Students will be expected to honor the commitment made in their Student Learning Agreement. Regular attendance, timely completion of assigned work, and thorough preparation for and participation in all mandatory program activities will be required.

UNIVERSITY FACILITIES

Students must follow the guidelines issued by any University service facility which they interact, such as libraries, dining services, etc.

STUDENT CONDUCT

The ideas of different members of the Foresight Prep community may conflict, and individual students may at times find some ideas disagreeable or offensive. There are, however, some circumstances in which behavior violates our community's policies. These include acts of violence, and explicit threats of violence, directed to a particular individual that compromise that individual's safety or ability to function within the program, and that persist after the individual has asked that it stop. Any conduct, on or off campus, of students as individuals and as members of Foresight Prep, that threatens the security of the community, the rights of its individual members, or its basic norms of integrity, can be subject to disciplinary action (see below).

UNLAWFUL DISCRIMINATION AND HARASSMENT

Foresight Prep conforms to the law in regard to nondiscrimination and maintaining an environment free from sexual harassment and other unlawful forms of harassment and discrimination. Foresight Prep does not discriminate on the basis of race, color, religion, sex, sexual orientation, gender identity, national or ethnic origin, age, disability, veteran status, or other protected classes under the law. Such discrimination is unlawful. Unlawful harassment based on one of the factors listed above is verbal or physical conduct that is so severe or pervasive that it has the purpose or effect of unreasonably interfering with an individual's program participation, or that creates an intimidating, hostile, or offensive work or educational environment. A person's subjective belief that behavior is offensive, intimidating or hostile does not make that behavior unlawful harassment. The behavior must be objectively unreasonable. Unlawful harassment

includes same sex harassment and peer harassment among students, staff or faculty. Unlawful harassment by a faculty or staff member of a student over whom they have authority, or by a supervisor of a subordinate, is particularly serious.

Sexual harassment deserves special mention. Sexual harassment encompasses a range of conduct, such as unwanted touching or persistent unwelcome comments, e-mails, or pictures of an insulting or degrading sexual nature, which may constitute unlawful harassment, depending upon the specific circumstances and context in which the conduct occurs. For example, sexual advances, requests for sexual favors, or sexually directed remarks or behavior constitute sexual harassment when (i) submission to or rejection of such conduct is made, explicitly or implicitly, a basis for an academic or employment decision, or a term or condition of either; or (ii) such conduct directed against an individual persists despite its rejection.

RESIDENCE HALL POLICIES

Respect for Property

Damage or vandalism to University or private property, injury, or threats to residents or guests or endangering the lives of others will not be tolerated. Students, faculty and staff may not detach fixed furniture, surfaces, or remove University furniture from rooms. In the event furniture is moved, the University will charge a \$50 fine per piece, to be paid by the student. Skating, rollerblading, and biking are not permitted in the residence halls.

Entry by Loyola University Chicago Staff

The University reserves the right to allow authorized personnel to enter dorm rooms. When such entry is deemed necessary, the University will seek within all reasonable bounds to protect the occupant's privacy. Authorized University personnel may remove items that are in violation of federal, state, local, or university regulations. A reasonable effort shall be made to have the occupant in question present if their rooms are to be searched. The occupant will receive written notification from a University official after such entry is made and advised if authorized staff has discovered any violations or removed any items.

Quiet Hours

In order that students and RATAs might study and sleep undisturbed, quiet hours will be observed in the residence hall as follows:

- Sunday through Thursday: 10:00 PM until 6:00 AM
- Friday and Saturday: Midnight until 9:00 AM

Visitors

Students may invite peers to visit their rooms, but the total number of students in a given room should never exceed twice its number of occupants (i.e. for a two-person dorm, no more than four students total). Doors must remain open at all times while any student other than the room's occupants is inside. Visitors who are external to the program are not allowed during Foresight Prep.

Pets

Pets are not allowed in the residence hall and should not be brought to campus. Exceptions may be made for service animals—students should contact Foresight Prep program staff well in advance of the program, and indicate this need in their registration forms.

CHECK-INS, BUDDY SYSTEM, AND OFF-CAMPUS EXCURSIONS

The safety and health of Foresight Prep students is of primary importance. Students are expected to be on time and present for all formal check-ins, including (but not necessarily limited to) meals, class time, at the conclusion of free time periods, and curfew. Students who venture off campus within the surrounding neighborhood are expected to travel in pairs or groups. Clearly demarcated boundaries for the "surrounding neighborhood" will be communicated during program orientation. Students, including those who are

Chicago residents, are not permitted to travel beyond the surrounding neighborhood without faculty and staff accompaniment.

CURFEW

The program enforces a curfew from 10:00 PM to 6:00 AM Sunday through Thursday and from 11:00 PM to 6:00 AM Friday and Saturday. This is not a "lights-out" policy, and students are not confined to their rooms during these hours. However, they are expected to be in the residence hall. This policy is a way of ensuring that students are present and accounted for and that they have a chance to sign in with their RATA every night. The program curfew is in force for all participants, regardless of age.

FIRE SAFETY

Fire safety regulations, which will be discussed during orientation, must be followed. Tampering with fire safety equipment, including fire extinguishers, fire alarms and smoke alarms, is considered a crime.

PRIVATE PROPERTY

Neither Foresight Prep nor Loyola University Chicago can accept responsibility for damage, theft or loss of monies, valuables, or personal property. The protection of personal property is the individual's responsibility. Doors should be locked when you leave the room. Do not leave clothes unattended in the laundry rooms or bathrooms. Books, backpacks, and other personal items should not be left unattended in meeting rooms, libraries, or dining areas. Report any theft to Campus Safety as soon as possible.

COMPUTING

Foresight Prep students will have access to the University's computing network during the length of their program. Parents and students should be aware that neither Foresight Prep staff nor the University monitor or censor in any way any electronic material. Some individuals may find the content of some electronic entries to be objectionable, including comments that may be construed as profane, obscene, racist, sexist, or otherwise offensive. Students should use the University's computing network recognizing that these materials exist and can be accessed, and that neither the University nor Foresight Prep assume responsibility for nor endorse any of the content in electronic entries.

Federal law requires that the University take action when notified that someone on its network is distributing copyrighted materials. If you acquire and/or redistribute copyrighted materials without buying or licensing them, you can be found in violation of the University's Computing Policy, which means you will no longer be able to use University computing facilities, including campus Wi-Fi, while you are a student in the program.

TRAVEL OFF-CAMPUS

Foresight Prep places a strong emphasis on community-building. Students are expected to remain on campus and/or with their peers for weekend social activities and free time. Parents and guardians should schedule any recreational and/or educational (e.g. college visits) activities in Chicago for before or after the seminar. Students from Chicago should only visit their homes in situations of necessity.

KEYS, KEY CARDS, & MEAL CARDS

Upon check-in, students will be given a key holder that includes their key(s) to enter their room, as well as a key card for entry into the dorm building, and other facilities such as the library. They will also receive a meal card. Students should carry and closely safeguard all three items at all times. If a key or key card is lost or stolen, it must be reported immediately to staff or faculty. Please be advised that a charge for lost keys and key cards is levied by the University. The standard fee is \$120 for each lost key, \$130 key card and \$50 replacement charge for a meal card lost prior to students' departure. Students will be responsible for these fees.

ALCOHOL AND OTHER DRUGS

Possession or use of alcohol or controlled substances is strictly prohibited. Federal and state laws prohibit the possession, distribution and use of controlled substances, unless in compliance with licensing requirements or a doctor's prescription. Illinois law prohibits the consumption and possession of alcohol by persons under the age of 21 and the supplying of alcohol to any person under the age of 21. Additionally, Illinois law prohibits the sale of alcoholic beverages except by those licensed to sell such beverages. Illinois law and city ordinances also prohibit public intoxication, operation of a vehicle or bicycle under the influence of alcohol or other intoxicants, and consumption of alcohol in a public place.

Loyola University Chicago is a tobacco free campus. The use of all tobacco products by students, staff, faculty, and visitors is prohibited in all buildings, facilities, properties, and vehicles owned or operated by Loyola University Chicago; on all campus grounds, including at outdoor athletic events and programs held on college property; in all campus facilities or on campus grounds being used for private events.

FIREARMS AND DANGEROUS OBJECTS

The possession, display, and/or use of dangerous objects including, but not limited to, firearms (including BB or pellet guns), fireworks, smoke bombs, explosives, ammunition, hunting knives, swords, sabers, or anything that could be perceived or misrepresented as a weapon is prohibited on Loyola University Chicago property.

RELATIONSHIPS

While Foresight Prep respects young people's autonomy, romantic and sexual relationships between students are discouraged, as in such a short timeframe, they may prevent students from bonding with diverse peers. Romantic and/or sexual behavior which discomforts or disrupts the Foresight Prep community, and/or threatens students' health and safety, could be cause for disciplinary action.

SOCIALIZING OUTSIDE FORESIGHT PREP

Students may encounter young people from other summer programs. While they are permitted to engage casually, the majority of their time should be spent with their Foresight Prep peers. Foresight Prep staff may intervene should this become a source of disruption.

DISCIPLINARY ACTION

If a student exhibits behavior inconsistent with the policies contained herein, Foresight Prep faculty or staff will intervene and discourage such actions. Any behavior that constitutes a threat to students' safety and well-being will be immediately communicated with their parent/guardian. In cases where a student's behavior, in the judgment of Foresight Prep's team, fails to meet established expectations, displays disregard for the warnings of the staff and faculty, or reflects a serious infraction of the program's policies, the matter may require deeper intervention that involves the full Foresight Prep faculty and staff, and potentially peers, as relevant. Foresight Prep staff and faculty will consult with appropriate parties, and

make every effort to resolve the situation with a minimum of punitive action, and with the goal of strengthening and improving the community as a whole. In extreme situations, such decisions as dismissal or expulsion may be warranted. Dismissed or expelled students receive no refund of their tuition fees. They will remain responsible for any and all remaining balances owed to the Foresight Prep.

Student Learning Agreement

EXPECTATIONS

Foresight Prep will require you commit fully to the following in order to be successful:

- Adhere to all social and academic policies outlined in this handbook;
- Attendance and active participation in all Foresight Prep classroom sessions and activities;
- Practice personal wellness and self-care (e.g. exercise, sufficient sleep);
- Contribute fully to group discussion and project work;
- Stay open to constructive criticism, and acknowledge your own limitations and potential areas for growth;
- Complete assignments and meet project deadlines as required;
- Promptly and fully communicate any issues that arise to Foresight Prep staff and faculty, and to group members as relevant;
- Seek help/support for any challenges that arise that may affect your participation; and
- Hold yourself accountable for achieving personal goals.

COMMITMENTS

Foresight Prep staff and faculty commit to upholding the following:

- All social and academic policies outlined in this handbook;
- Opportunities for experiential learning, networking with established professionals, and personal development;
- Facilitation of a respectful and inclusive space conducive to exploration, learning and growth;
- Clear communication with students regarding expectations, including feedback to inform project goals;
- Respect for students own assets, skills, and leadership potential; and
- Openness to constructive feedback.
